Delegation of Authority

All enforcement is carried out according to Standard terms of parking enforcement agreed upon between the branch organisations and The Consumer Council of Norway. EuroPark AS is member of NORPARK, the Norwegian member of European Parking Association.

These are the major public authorities EuroPark AS are effecting parking enforcement on behalf of:

- Norwegian Airport authorities (Avinor) at Norway's 5 largest airports: Oslo Airport Gardermoen, Bergen Airport Flesland, Trondheim Airport Værnes, Stavanger Airport Sola and Tromsø Airport Langnes.
- Authorities at Norway's largest Airport owned by a county: Sandefjord Airport Torp.
- Harbour authorities in the cities of Oslo, Stavanger and Horten.
- Hospital authorities operating 7 of the largest hospitals owned by the Norwegian government in the cities of Oslo (Rikshospitalet), Lillehammer, Moss, Fredrikstad, Fredrikstad/Veum, Sarpsborg and Halden.
- Railroad authorities in the cities of Oslo, Hamar and Lillehammer; and the municipalities of Asker, Brumunddal and Moelv.
- Other governmental and municipal departments.

I hereby confirm that delegated authority has been given for EuroPark AS to issue Penalty Charge Notices on behalf of the authorities listed above. Furthermore, I hereby confirm that EuroPark AS, in such capacity has appointed Euro Parking Collection Plc to carry out the tracing and collection of Parking and Traffic contraventions committed by drivers of foreign registered vehicles and rental cars on behalf of these authorities.

This authority is given in accordance with the terms set out in the agreement between the actual authority and EuroPark AS.
