

Please accept this document as formal Authorisation for APCOA Parking to execute Private Land Enforcement and debt recovery activity on land owned or managed by our organisation. This letter also outlines our expectation that this enforcement activity is conducted in line with the BPA's Approved Operator Scheme, and that data is held and used only in accordance with prevailing Data Protection legislation.

This parking control will involve the issuing of Private Land Enforcement Notices only. Clamping is not to be utilised.

The land on which APCOA may operate on our behalf consists of the following:

- Against over-stay in the DoZ shown orange on the attached plan; and
- Against parking and stopping on the roads shown yellow on the attached plan; and
- Against unauthorised vehicles entering the Central Terminal Area also shown coloured yellow on that same plan.

All Emergency Service vehicles are exempt from above.

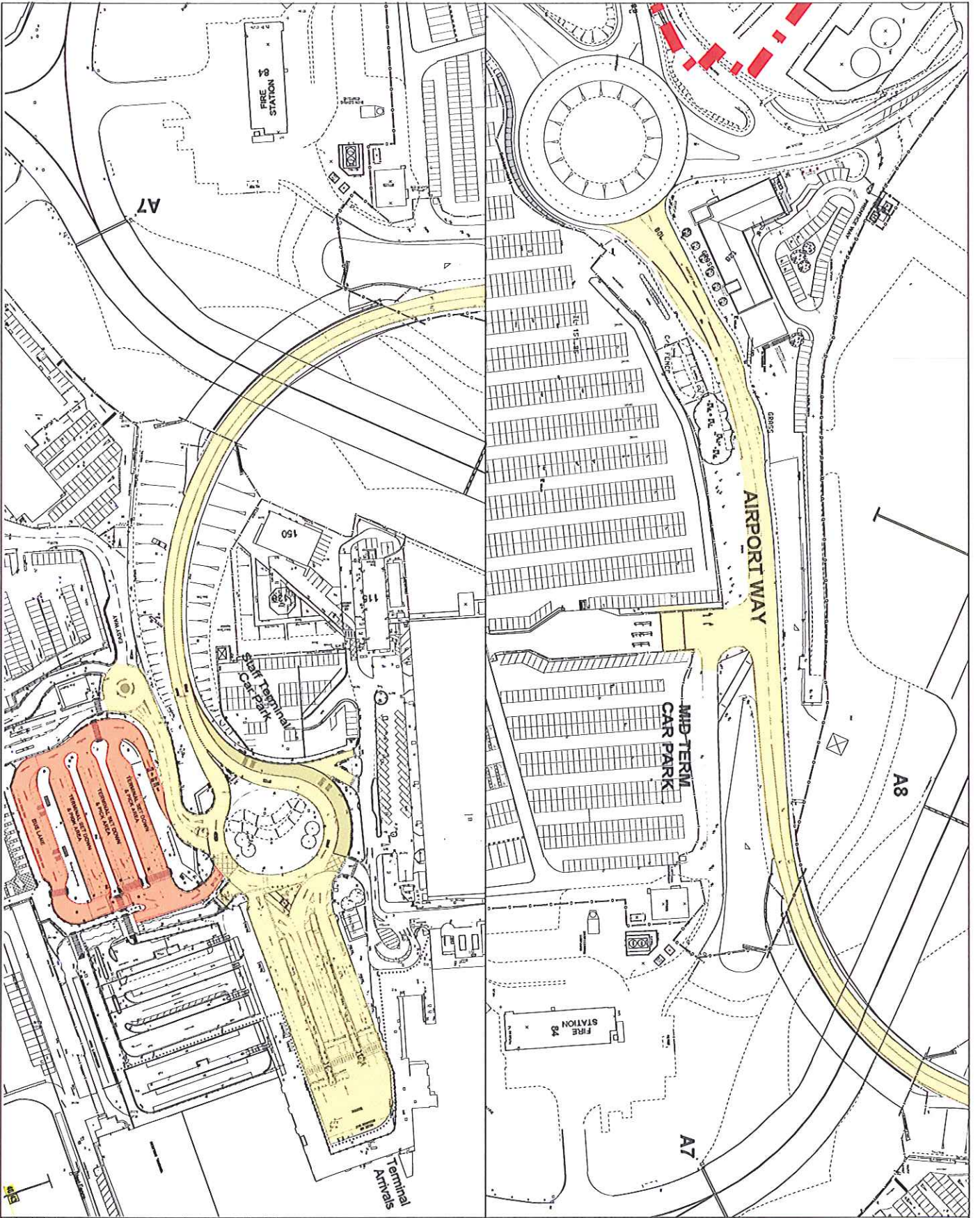
We acknowledge LLAOL is responsible for the erection and maintenance of signage, which was funded by LLAOL. This signage clearly states that the enforcement regime is in place at all times executed on our land.

We authorise APCOA to access DVLA data in the execution of their enforcement activity, and do authorise APCOA to take legal action in the recovery of unpaid Notices on our behalf.
