### POWER OF ATTORNEY

Euro Parking Collection plc of Shepperton House, 83-93 Shepperton Road, London N1 3DF, United Kingdom with its subsidiary Contractum Limited (hereinafter referred to as 'EPC Group'), with registration number GB3515275, Taxpayer Identification Number GB714351951, is hereby authorised, according to the Agreement number 2755 dated 20.02.2015 with its Annexes (hereinafter referred to 'Agreement'), to take all legal proceedings for the collection of due debts owed to the Public Utility Company For Public Garages and Parking 'PARKING SERVIS' with the headquarters at 7 Kraljice Marije St, Belgrade, mail receipt address Belgrade, 27 Kneza Visaslava, by debtors – the parking services users whose vehicles have foreign registration plates and who have outstanding debts to PUC 'Parking Servis' Belgrade for unpaid parking services in Belgrade's zoned areas and/or for issued additional/daily parking cards in accordance with the Decision on Public Parking Lots in the territory of the City of Belgrade.

In the collection proceedings of due debts in accordance with Paragraph 1 herein, 'EPC Group' shall act in the name and on behalf of the PUC 'Parking servis' of Belgrade and is authorised to undertake all necessary legal actions in order to determine the debtor's identity, to obtain all relevant data from the competent institutions, to send notifications to the debtors and to collect the debts in compliance with the obligations and authorisations provided for by the Agreement.

For the debtor identification purposes, 'EPC Group' is authorised to gather data on Polish vehicle owners registered with CEPIK ( Centralna Ewidencja Pojazdów i Kierowców).

In order to collect debt from debtors, and for the purposes of representation before the competent state bodies, administrative bodies and courts, as well as taking all legal actions in accordance with the Agreement, 'EPC Group' can engage lawyers and persons authorised by such lawyers as their deputies.

The mutual relationship between 'EPC Group' and such engaged lawyers shall constitute no obligation on the part of PUC 'Parking servis' for fulfilling any obligations whatsoever towards the engaged lawyers and their deputies, and in accordance with the Agreement, the sole responsibility for the fulfilment of obligations towards the PUC 'Parking servis' rests with 'EPC Group'.

This Power of Attorney shall supersede the Power of Attorney No. 2755/1 dated 20.02.2015.

## PUNOMOĆJE

Ovim se ovlašćuje Euro Parking Collecttion plc of Shepperton House, 83-93 Shepperton Road, London N1 3DF, United Kingdom sa svojom podružnicom Contractum Limited (u daljem tekstu "EPC Group"), MB GB3515275, PIB GB714351951, da shodno zaključenom Ugovoru br. 2755 od 20.02.2015. godine, sa pripadajućim Aneksima (u daljem tekstu: Ugovor), preuzima sve pravne radnje u postupcima naplate dospelih potraživanja koja Javno komunalno preduzeće za javne garaže i parkirališta „PARKING SERVIS“ – Beograd, ul. Kraljice Marije broj 7, adresa za prijem pošte Beograd, Kneza Višeslava 27, ima prema dužnicima - korisnicima usluga parkiranja sa vozilom inostranih registarskih oznaka, a koja imaju dugovanja prema JKP "Parking servis" Beograd, po osnovu neplaćenih usluga parkiranja u zoniranom području grada Beograda, odnosno izdatih doplatnih/dnevni karata u skladu sa Odlukom o javnim parkiralištima na teritoriji grada Beograda.

U postupcima naplate dospelih potraživanja od dužnika u smislu stava 1., "EPC Group", će nastupati u ime i za račun JKP „Parking servis“ Beograd i ovlašćen je da preuzima sve pravne radnje u cilju identifikovanja dužnika, pribavlja sve relevantne podatke od nadležnih institucija, upućuje opomene dužnicima i vrši naplatu potraživanja, sve u skladu sa preuzetim obavezama i u sklopu ovlašćenja definisanih Ugovorom.

"EPC Group" se ovlašćuje da u cilju identifikovanja dužnika, pribavlja podatke i o vlasnicima poljskih vozila koja su registrovana u CEPIK ( Centralna Evidencija Pojazdow I Kierowcow).

U cilju naplate potraživanja od dužnika, a radi zastupanja pred nadležnim državnim organima, organima uprave i sudovima, kao i preuzimanja svih pravnih radnji u skladu sa Ugovorom, "EPC Group" može angažovati advokate i lica koja advokati odrede kao svoje zamenike.

Međusobni odnosi "EPC Group" i angažovanih advokata ne obavezuju JKP "Parking servis" na izvršavanje bilo kakvih obaveza prema angažovanim advokatima i njihovim zamenicima, a shodno zaključenom Ugovoru, isključivu odgovornost za ispunjenje obaveza prema JKP "Parking servis-u" snosi "EPC Group".

Stupanjem na snagu ovog Punomoćja prestaje da važi Punomoćje br. 2755/1 od 20.02.2015. godine.
